

# PLUS (Parent) Loan Request And Loan Funds Release Authorization

Fall 2019/Spring 2020

#### To receive a PLUS loan at ASU-Newport your child must:

- 1. Be seeking a degree or technical certificate at ASU-Newport
- 2. Be enrolled in at least six hours

#### ASU-Newport PLUS Loan Information, PLUS Loan Request Form and Release Authorization

PLUS loans are federal loans that graduate or professional degree students and parents of dependent undergraduate students can use to help pay education expenses. The U.S. Department of Education makes Direct PLUS Loans to eligible borrowers through schools participating in the *Direct Loan* Program.

- The U.S. Department of Education is the *lender*.
- The borrower must not have an adverse credit history.
- The maximum loan amount is the student's cost of attendance (determined by the school) minus any other financial aid received.

To receive a Direct PLUS Loan, you must

- be the parent (biological, adoptive, or in some cases, stepparent) of a dependent undergraduate student enrolled at least halftime at a participating school; and
- your child must also meet the general eligibility requirements for federal student aid

#### To take out a Direct Loan for the first time, you must complete a PLUS Application and master promissory note (MPN).

A Direct PLUS application is a request for supplemental information that the school uses to determine your eligibility for a Direct PLUS loan.

The MPN is a legal document in which you promise to repay your loan(s) and any accrued interest and fees to the Department. It also explains the terms and conditions of your loan(s). The MPN will be provided either by your child's school or the Department.

Parents should complete the PLUS application and MPN electronically online at <a href="www.studentloans.gov">www.studentloans.gov</a>. If you are borrowing Direct PLUS Loans for more than one student, you'll need to complete a separate MPN for each one. To complete an MPN online, you will be required to use your Department of Education-issued PIN (not your child's). If you do not have a PIN, you may request one from the official PIN site.

In most cases, once you've submitted the MPN and it's been accepted, you won't have to fill out a new MPN for future loans you receive to pay for the educational expenses of the same student. Unless your child's school does not allow more than one loan to be made under the same MPN, you can borrow additional Direct Loans on a single MPN for up to 10 years.

You'll receive a disclosure statement that gives you specific information about any loan that the school plans to disburse under your MPN, including the loan amount and loan fees, and the expected loan disbursement dates and amounts.

#### Credit check & endorser alternative

When you apply for a Direct PLUS Loan, the Department will check your credit history. To be eligible for a PLUS Loan, you must not have an adverse credit history. If you are found to have an adverse credit history, you may still borrow a PLUS Loan if you get an endorser who does not have an adverse credit history. An endorser is someone who agrees to repay the Direct PLUS Loan if you do not repay the loan. The endorser may not be the student on whose behalf a parent obtains a Direct PLUS Loan. In some cases, you may also be able to obtain a Direct PLUS Loan if you document to our satisfaction that there are extenuating circumstances related to your adverse credit history.

- 2. Borrowers must complete a Master Promissory Note (MPN) and PLUS loan application at <a href="www.studentloans.gov">www.studentloans.gov</a>
- 3. Return completed PLUS loan request and release form to the ASUN financial aid office.
