- Incomplete forms and/or documents will delay the continued processing of your financial aid.

**NOTE:** The best way to verify income is by using the IRS Data Retrieval Tool (DRT) on the FAFSA. If you have not already used the tool, go to www.fafsa.ed.gov, log in to the 2020-21 FAFSA record, select "Make FAFSA Corrections," and navigate to the Financial Information section of the form. From there, follow the instructions to determine if you are eligible to use the IRS DRT to transfer

2018 IRS income tax information into the FAFSA. After uploading tax data, please be sure to sign and submit the FAFSA. For electronic Tax Filers, it takes up to two weeks for IRS information to be available for the DRT; for paper Tax Filers, up to eight weeks. If you have questions, please contact the ASUN Financial Aid Office.

Alternatively, you may request a 2018 Federal Tax Return Transcript directly from the IRS – not a photocopy of your tax return. To obtain an IRS tax return transcript, go to www.IRS.gov and click on the "Order a Return or Account Transcript" link, or call 1-800-908-9946. Make sure to request the "IRS tax return transcript" and not the "IRS tax account transcript." You will need your Social Security Number, date of birth, and the address on file with the IRS (normally this will be the address used when the 2018 IRS tax return was filed). It takes up to two weeks for IRS income information to be available for the electronic IRS tax return filers, and up to eight weeks for paper IRS tax return filers.
